

PRESENTATIONS:

1. Hinricher, Douglas & Porter, Certified Public Accountants to present audit report for fiscal year ended June 30, 2014 – Castroville CSD's annual financial audit was recently completed and presented to the Board of Directors at the November 18, 2014 board meeting by Certified Public Accounts Gary Porter and Brian J. Cousino with Hinricher, Douglas & Porter. Per Mr. Cousino, Castroville CSD received a clean audit and opinion, which is issued by an auditor when the financial statements presented are free from material misstatements and are represented fairly in accordance with Generally Accepted Accounting Principles (GASB). In other words, Castroville CSD's financial condition, position, and operations are fairly presented in their financial statements. It is the best type of report opinion an

auditee may receive from an external auditor. There were no internal control deficiencies "findings" and no management improvement recommendations. Mr. Cousin asked if the Board had any questions or concerns. Director Betty A. MacMillan stated that the Office Manager does an excellent job. Mr. Porter stated that per their perspective, they have a lot of confidence in Castroville CSD's Office Manager. They deal with audits enough and with many different agencies and test to make sure the financial statements are reflected accordingly. They also evaluate the integrity of the people they are dealing with; although they are certainly not behaviorist, but can get a feeling as to how people respond. Mainly, looking to see if they are being honest with you or trying to handle you with smoke and mirrors. He also stated that whenever the Office Manger has a question, she gives them a call. He feels they have a very good, open, and honest relationship established with Castroville CSD staff. He also discussed briefly the implementation of GASB 68 for fiscal year June 2015. Footnote 9 on page 30 of the notes to the financial statement mentions the implementation of GASB 68. Employers will be required to recognize a liability as employees earn their pension benefits (that is, as they provide services to the government). For the first time employers will recognize their net pension liability, deferred outflow of resources, deferred inflows of resources, and pensions expense. The complete financial audit including the Management, Discussion and Analysis (MD&A) is available on the District website, www.Castrovillecsd.org.

2. Update on well levels – General Manager Eric Tynan informed the Board on the current well levels. Well #2 is up 6 feet and currently 11 feet below sea level, Well #3 is up 4 feet and 33 feet below sea level and Well #4 is down 1 foot and 38 feet below sea level. Some of the well levels are going up a little due to the lack of pumping from the farmers at this time. General Manager Eric Tynan will continue to update the Board on the well levels at the next board meeting.
3. Update on Prop 84: Well 5 (formerly Well 2B) Arsenic Treatment project – General Manager Eric Tynan informed the Board that the Department of Water Resources has assigned a new project manager, which will hopefully get the Prop 84 grant funding project moving forward. The Wallace Group is reviewing different technologies to use for the arsenic treatment of Well 5 and will recommend the best solution for the Well 5 arsenic treatment. He also had the operations department trench and install the well pump power cable.
4. Update on mural project for Castroville walkway over Highway 156 – General Manager Eric Tynan reported to the Board as mentioned at the last few board meetings; Caltrans is requiring a traffic, air and lead study by Castroville CSD before they would consider moving forward with this project. This project currently has a budget of \$12,500 and all these additional requirements would likely end this project. General Manager Eric Tynan proposed to Caltrans that they prep the wall for this project. He is still waiting to see if they will consider this request and has received no response as of yet. Mr. Grant Leonard suggested that Castroville CSD attend a Transportation Agency for Monterey County (TAMC) public meeting and offer a partnership to work on this project with them. Per Mr. Leonard the next public meeting for TAMC is scheduled for December 3, 2014 at 9:00 a.m. at the Agriculture Center in Salinas. General Manager Eric Tynan and Director Ron Stefani stated they would both attend this meeting.
5. Update on tax measure for North Country Recreation and Park District (NCRPD) – General Manager Eric Tynan informed the board that the first week of January 2015, informational meetings will resume to discuss the tax measure for the North County Recreation and Park District (NCRPD).

6. Update on Castroville overhead sign - General Manager Eric Tynan reported to the Board that he is still waiting to have an engineer's stamped plan to verify the structural integrity of the sign as requested by Caltrans.
7. Update on the site review of the infrastructure deficiencies of the Pajaro County Sanitation District – General Manager Eric Tynan notified the Board that he and Operator II Roberto Galvez had separately viewed the Pajaro County Sanitation District. General Manager Eric Tynan reported to the Board the various infrastructure deficiencies that exist with the Pajaro County Sanitation District and also presented them with pictures to view that were taken by Operator II Galvez. In addition, he also showed the Board a letter from Pajaro Sunny Mesa CSD addressed to the County. Pajaro Sunny Mesa CSD is currently operating under contract with the County to operate the Pajaro County Sanitation District but has given them written notice to cancel the contract due to the liability of operating and maintaining such a poor system. Furthermore, no agencies responded to the County's two proposals; (RFP #10502) maintenance and operation of the Pajaro County Sanitation District or (REI #PWO2) ownership of the Pajaro County Sanitation District and/or Boronda County Sanitation District. Director Betty MacMillan thought that the Board already had taken action at the last board meeting not to express any interest of ownership of the Pajaro County Sanitation District and especially with the information provided today by General Manager Eric Tynan. In her opinion, Castroville CSD just needs to stay where it is. President David Lewis thought it was an option that was worth looking into. The action taken at the October 21, 2014 board meeting still stands; not to express interest to assume ownership and operational responsibility for the Pajaro County Sanitation District. General Manager Eric Tynan just wanted to provide the Board with more detailed information on the system. Also, the County showed appreciation that Castroville CSD at least took the time to tour the system.

NEW BUSINESS:

1. Review current Moss Landing Wastewater Treatment Capacity Allocation Plan – General Manager Eric Tynan informed the Board that per the draft copy of the Moss Landing Community Plan, section 4.2.3. Current Wastewater Treatment Capacity Allocation, The MLCSD (now Castroville CSD) provides sewer services to its five service areas based on a Coastal Commission-certified Sewer Allocation Plan (SAP), which was adopted in November 1984. The SAP allocates a certain volume of sewer flow to each of the five service areas based upon existing land use, expected future growth, and allocations for future priority uses. The reason the SAP was developed is that Moss Landing had a lot of septic tanks that were leaking and polluting the slough and neighboring properties. Eric stated that the limit is 105,000 gallons per day and he believes that it was limited due to the old Castroville treatment plant that is long gone. Moss Landing's MRWPCA pump station can currently handle 280,000 gallons per day and currently it is only at 79,000 gallons per day. There is plenty of capacity and this SAP is in need of an update to accommodate new and expanded development, address new technologies, account for existing usage, and retain capacity for vacant lots. Eric stated that the SAP is a little controversial; people think they have an entitlement in the service areas since they have been paying sewer fees even though they are not hooked-up. Per District Legal Counsel Lloyd Lowrey, the plan does not provide for allocations to specific properties, it provides for allocations within zones. It is a plan and the general rule in vested rights is that unless you have something that has been vested to a specific property, you do not have vested rights. There are certain vested rights provided for in code for certain kinds of planning activities. Although, he has not reviewed the whole background of the SAP, this kind of plan seems unlikely that there would be a finding of a vested right in connection with this plan. There would need to be a process to change the plan. Eric introduced to the Board, Management Specialist Martin Carver who has been employed with the County as of 2012. Mr. Carver is the lead person working to make draft changes to the Moss Landing Community Plan. The Moss Landing Community Plan process started in 2008 and then fell idle due to the recession. The Moss Landing Community Plan is in the EIR process and a meeting was held last July 2014 to respond to EIR issues better. The County also suggested for the first time for the Sewer Allocation Plan to be eliminated, which appears were the intentions of the plan in 2008 all along. These changes were included in the plan and republished and presented at the July meeting. The County got immediate concerns, in particular from the Moss Landing Harbor District and Mark Del Piero. However, they did meet with the Moss Landing Harbor District last month and had a very good productive meeting with them. Discussed was the topic of the Sewer Allocation Plan and that the County does not think the Sewer Allocation Plan is a proper tool anymore to regulate growth. A lot has changed since this plan was originally implemented. Those concerned seem to think by eliminating the Sewer Allocation Plan that somehow it will eliminate allocations that were guaranteed to specific properties. The preliminary work done on the EIR is not published yet. The analysis that they have in

draft form shows that there is plenty of treatment capacity at the regional plant. Mr. Carver stated he has been working closely with Eric on getting the EIR analysis right. It is going to be critical to get people to relax around the elimination of the Sewer Allocation Plan. The plan will need to show that there is sufficient treatment and conveyance capacity. One of the concerns is adding the Moss Landing Business Park, Nader Agha's property which is located across from Dolan Road from the power plant. Part of what the community recommended in 2008-2009 and part of what they have included in the plan is adding that property or suggesting that the Castroville CSD add this property to their service area. From what Mr. Carver understands, the existing Sewer Allocation Plan guarantees existing vacant lots of records a minimum of 250 gallons per day and does not show where it otherwise guarantees allocation to other sites. After much discussion, a motion is made by Ron Stefani and seconded by Betty A. MacMillan to authorize staff to move forward in modifying a plan to work with the County and community in forming a solid plan and a possible committee in regards to the Moss Landing Wastewater Treatment Capacity Allocation Plan. Dear Interested Party:

The Sustainable Groundwater Management Act ("SGMA") becomes effective January 1, 2015. It is comprised of three pieces of legislation and, although it requires the California Department of Water Resources to adopt regulations for implementation, we need to be proactive now.

In the near term, the SGMA requires a Groundwater Sustainability Agency for the Salinas River groundwater basin to be named prior to January 1, 2016. The Monterey Peninsula Water Management District is named in the SGMA as the Groundwater Sustainability Agency for the Carmel basin, as is the Pajaro Valley Water Management Agency for the Pajaro Basin.

The Monterey County Water Resources Agency would like to give you advance notice that it plans to hold an initial public informational meeting on January 21, 2015, with local governmental entities and interest groups to review the key aspects of the Groundwater Sustainability Act; seek input on options related to establishment of a Groundwater Sustainability Agency; and, develop next steps, including individual meetings with governmental agencies and interest groups.

While the Board of Directors of the Monterey County Water Resources Agency has recommended that it become the Groundwater Sustainability Agency for areas of Monterey County that are not covered by another Groundwater Sustainability Agency named in the SGMA, it may be beneficial in having a single entity serve as the Groundwater Sustainability Agency for the entire basin. The public process discussed herein will take place, and the SGMA required noticed public hearing will be held, before action by the Monterey County Water Resources Agency Board of Supervisors.

We will confirm the January 21, 2015 date and establish the time and location of the public informational meeting by separate correspondence in the future.

RICO STREET SIDEWALK IMPROVEMENT PROJECT

Construction work on the Rico Street Sidewalk Improvement Project between Merritt Street (State Route 183) and McDougall Street in Castroville will begin December 2nd and is expected to be completed by the end of January 2015.

The project is under the direction of the Monterey County Resource Management Agency – Public Works and includes curb, gutter, sidewalk, drainage, driveways, relocation of signs, handicap ramps and other roadway improvements. During the course of the project, temporary traffic control measures including lane closures may be needed. Local residents will continue to have access to this road section during the construction period however, other motorists are encouraged to seek alternate routes such as Merritt Street (State Route 183) and adjacent streets, during the construction period.

The total cost of the Rico Street Sidewalk Improvement is \$181,676, which is funded by a Livable Communities Grant from the Transportation Agency for Monterey County and Gas Tax Funds. The Don Chapin Company, from Salinas, California, was awarded the construction contract in the amount of \$118,151.

The water bond: what's next for the Salinas Valley?

On Nov. 4, California voters passed a mammoth \$7.5 billion water bond that had been written and re-written for five years.

From a bird's eye view, its purpose is relatively straightforward: increase the state's water supply, water access, and watershed protection. But the bond's impact on the Salinas Valley is far from certain, and a snag in complying with state regulations may make some county projects ineligible.

The lion's share of the bond, \$2.7 billion, will go toward expanding the state's water storage capacity. Front-runners for this pot of money include the Sites Reservoir near Sacramento and Fresno's Temperance Flat dam — large-scale water-trapping projects that would not directly influence water supply in our neck of the woods. But in reality, said Norm Groot of the Monterey County Farm Bureau, water that helps some California farmers helps all of them — including the many growers in the Salinas Valley.

"We're fine with that because it does help overall water supply solutions throughout the state," said Groot in an interview in late October.

The bond allocates \$43 million directly to the Central Coast hydrologic region, a 40-mile-wide strip of coastline from Santa Cruz to Santa Barbara. Groot said county officials are prepared with a long list of projects that would qualify, including the Salinas River Stream Maintenance Program that recently broke ground on a pilot project near Chualar. "Really, the benefits are for all the residents and citizens of the county, not just the landowners along the river," Groot said. Other projects would protect sensitive slough ecosystems and recycle wastewater to reduce seawater intrusion.

At least \$696 million is available for disadvantaged communities, which would get the added benefit of a reduced or waived cost share below the 50 percent required by the rest of the bond. This provision is especially important for communities like the San Jerardo Cooperative, Alpine Court and San Vicente Road, plagued by nitrate contamination and failing septic systems. Assemblymember Luis Alejo, D-Watsonville, said he's particularly excited about the

opportunities for these communities. "They've been trying to get state money for decades," he said.

One of the biggest Salinas Valley projects on the table is the \$48-million to \$63-million Interlake Tunnel set to connect Lakes Nacimiento and San Antonio. The two reservoirs fill at different rates, so a 12,000-foot tunnel moving water between them would help increase their combined capacity.

"We're hoping to get resources for the Interlake Tunnel," said Robert Johnson of the county Water Resources Agency, though the county is prepared to fund the tunnel by raising water rates for valley farmers.

But the county won't be eligible for bond money until it complies with CASGEM, a state groundwater monitoring program in effect since 2011. The program requires local agencies to regularly report groundwater levels wells dipping into the state's water basins.

"It really comes down to sustainability of the water supply," said Lauren Bisnett of the state Department of Water Resources (DWR). But in Monterey County, many wells here are private, so data is proprietary. Both Bisnett and Johnson confirmed they're working on finding a solution. But until then, county projects will be ineligible for any state funding — including emergency drought relief.

Despite the unknowns, one thing is certain: no one will receive a dollar for quite some time. The bond is massive, and its oversight has been fragmented among DWR, the California Water Commission, and state Water Resources Control Board, along with others. Each agency will be soliciting proposals, reviewing applications, and awarding its own grants, processes that could take months to years to implement.

The water bond will address many problems, but no panacea exists in a state with a limited water supply and an ever-increasing population. And with an undefined timeline, it won't provide any relief from the current drought. Only time will tell if 67.2 percent of voters made the right choice.

It seems like a simple, verifiable fact necessary to inform drought discussions: How much of California's water supply goes to agriculture?

Trying to answer that tidy little question leads straight into controversy. California's age-old water wars are heating up amid punishing drought, and that bubbles all the way down to the definition of what "applied water" really means.

That's the term the California Department of Water Resources used in its 2013 water plan to refer to water that is "diverted from any source to meet the demands of water users without adjusting for water that is depleted, returned to the developed supply or considered irrecoverable."

The department includes water dedicated to the environment — fish flows in rivers, flows into wetlands, minimum flows into San Francisco Bay and the like — in the total. Using this way of calculating it, environmental water use in 2010 — an average precipitation year — was 38.7 million acre-feet.

An acre-foot is enough water to cover a perfectly flat acre of land 12 inches deep.

So it's 38.7 million acre-feet to the environment, 32.9 million acre-feet to agriculture and 8.3 million acre-feet to urban/industrial uses. That's 48.4 percent to the environment, 41.2 percent to agriculture and 10.4 percent to urban/industrial.

Ag-friendly groups like the California Farm Water Coalition use the department's accounting to demonstrate that environmental uses are now receiving more developed water than agriculture (Once upon a time, it was the other way around).

But many environmental groups and media reports routinely state that agriculture uses about 80 percent of California's developed water supply. They count agriculture

and urban/industrial as developed water, but leave out environmental water, arguing that it belonged to the natural ecosystem anyway.

One of the groups using the 80 percent calculation is the Pacific Institute, an Oakland think-tank emphasizing sustainable use, recycling and conservation.

Heather Cooley, the institute's water program director, said the traditional way of measuring developed water is to add up the total water extracted from the natural environment and put to direct human use.

"I think the difference really comes down to what you are including in the denominator," she said. "Some people think of the environment more as the source of the water."

Over at the California Farm Water Coalition, there's a different view of environmental water. To Mike Wade, the organization's executive director, it's water controlled by human beings who then devote it to uses they deem appropriate — in this case, sustaining a healthy environment.

"Everybody thinks that the environment is this thing out there that is untouchable, that we shouldn't talk about it," Wade said.

Wade said the back-and-forth about 80 percent vs. 40 percent hasn't let up in the 16 years he's been executive director of the coalition.

If anything, drought has made the discussion tougher as both sides ask for more surface water from a state government trying to strike a fine balance between human consumption and environmental preservation.

Wade has championed an approach requiring that environmental water use be audited in the same way that agricultural water use is monitored for efficiency. He doesn't seem to be winning over many converts in the environmental community to his approach.

As the debate rages on about the definition of developed water and how much ought to go to the environment, Cooley thinks there's room for improvement in at least one area: accurately measuring and reporting how much water is being used.

Groundwater use is estimated and included in the Department of Water Resources statistics, for example, but the agency admits that there isn't a lot of hard data on exactly how much is being pumped out in any given year.

The statewide groundwater sustainability law passed earlier this year aims, in part, to close that gap — one of the many unknowns in California's water world.

The same could be said for studies about just how much water fish, birds, plants and other organisms need to survive.

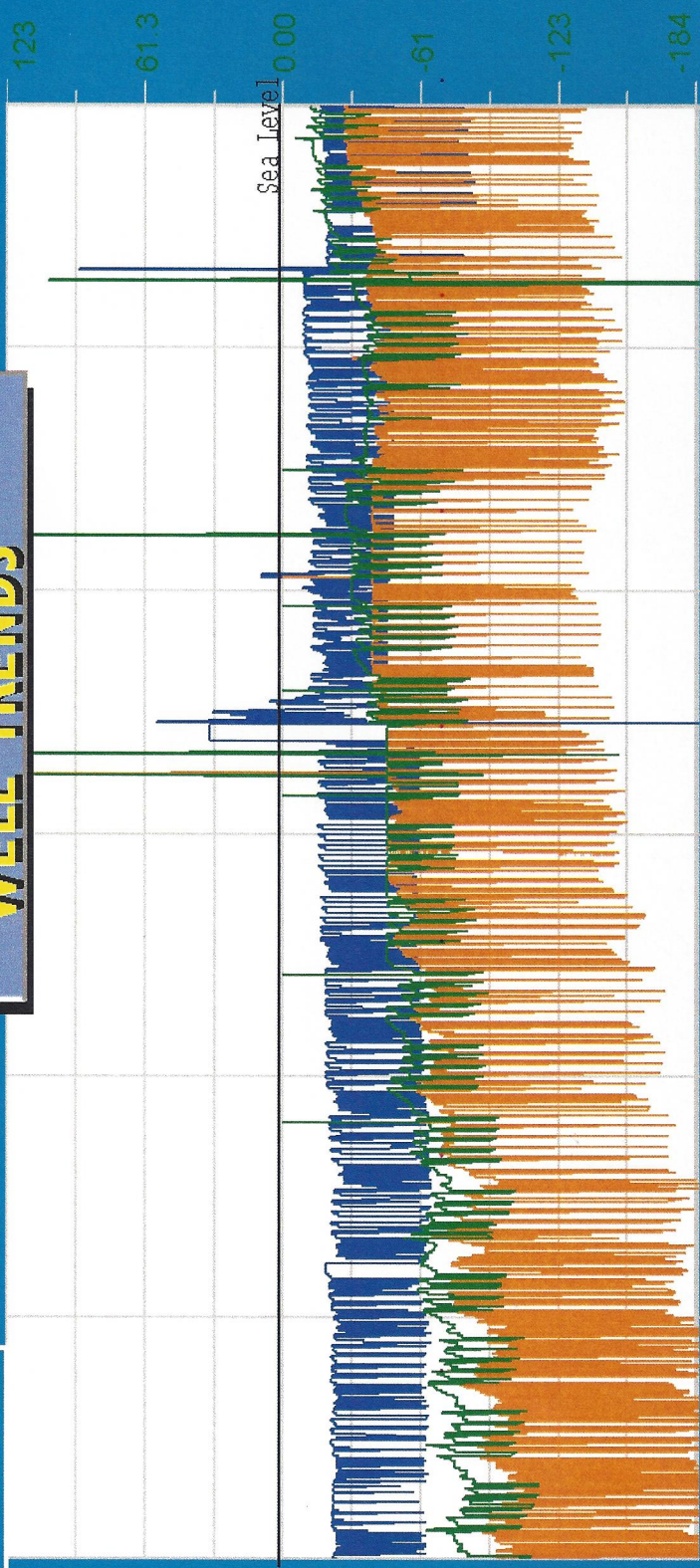
"There are challenges," Cooley said. "I think we're getting better."

Per our email correspondences, I am setting forth a quick summary of our next steps to prepare for the elimination of Sewer Allocation System that is currently in place for Moss Landing. This work program is premised on Monterey County successfully adopting its updated Moss Landing Community Plan and obtaining certification of the revised plan from the California Coastal Commission.

- Task 1: Conduct a thorough review of the existing provisions and prepare an underline/strikeout version of the regulations. RMA will work closely with CCSD on the preparation of this document.
- Task 2: Undertake a feasibility study to determine the effects of eliminating the Sewer Allocation Plan. This should include a financial analysis, a legal analysis, and an analysis of any impact to services (existing and future) that may result from the proposal. This should also incorporate any analysis that is completed as part of the Moss Landing Community EIR process.
- Task 3: Present the proposed language revisions and the results of the feasibility analysis to the CCSD Board as part of a workshop on the topic.
- Task 4: Present the proposed language revisions and the results of the feasibility analysis to the Moss Landing Community.
- Task 5: Ask CCSD Board to take final action on the matter

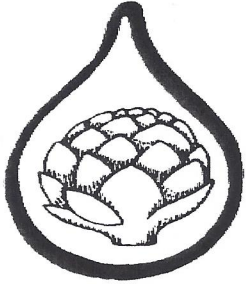


Million Gallons

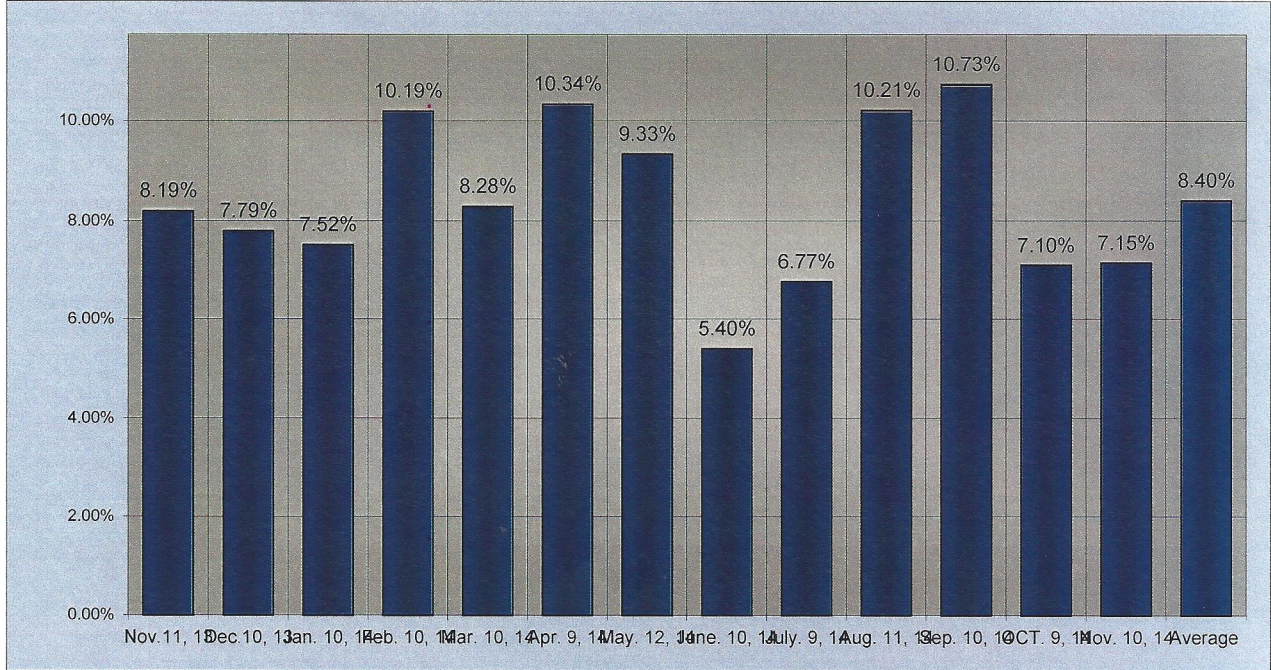


Percent Water Loss

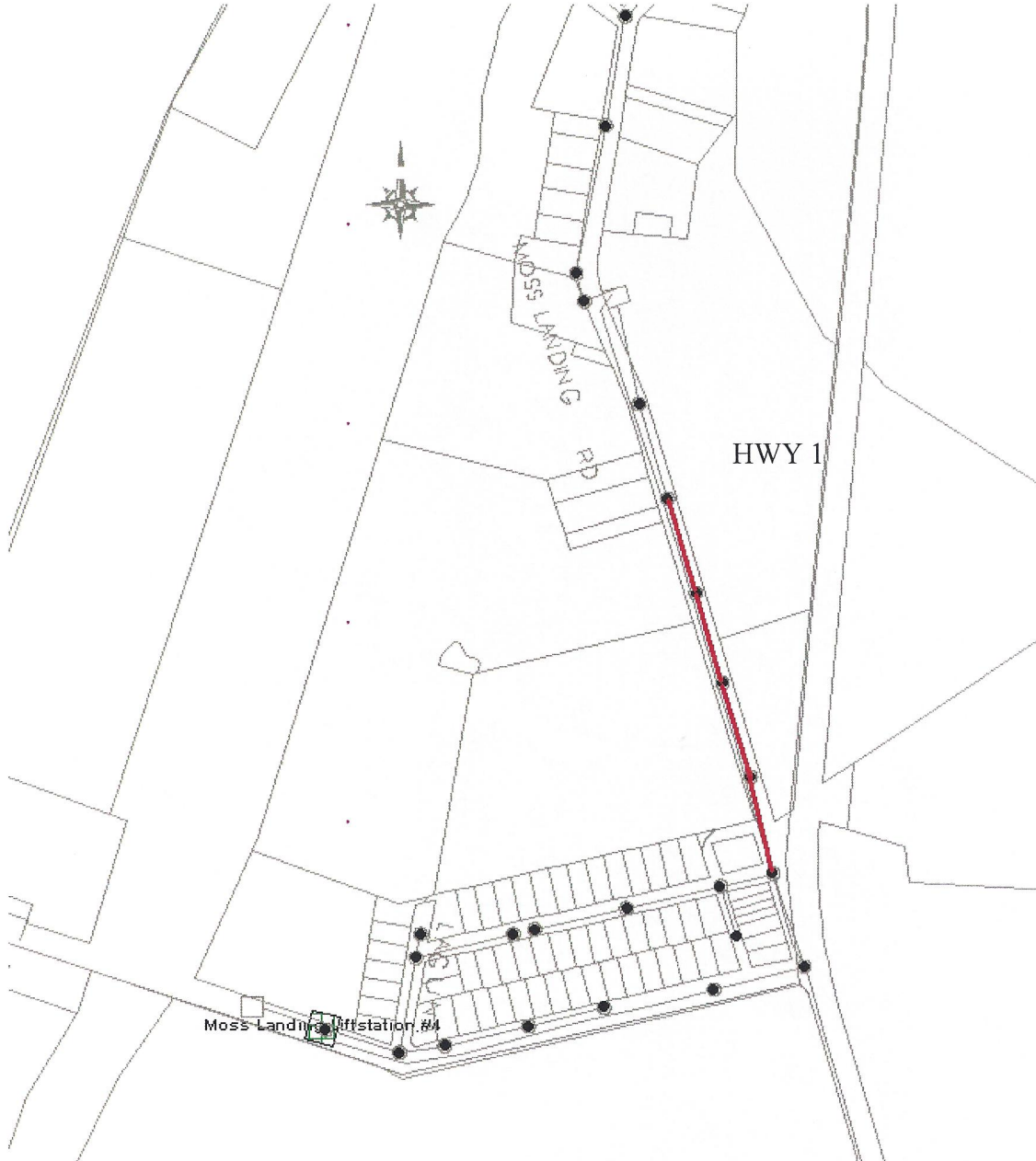


Sewer Jetted lines

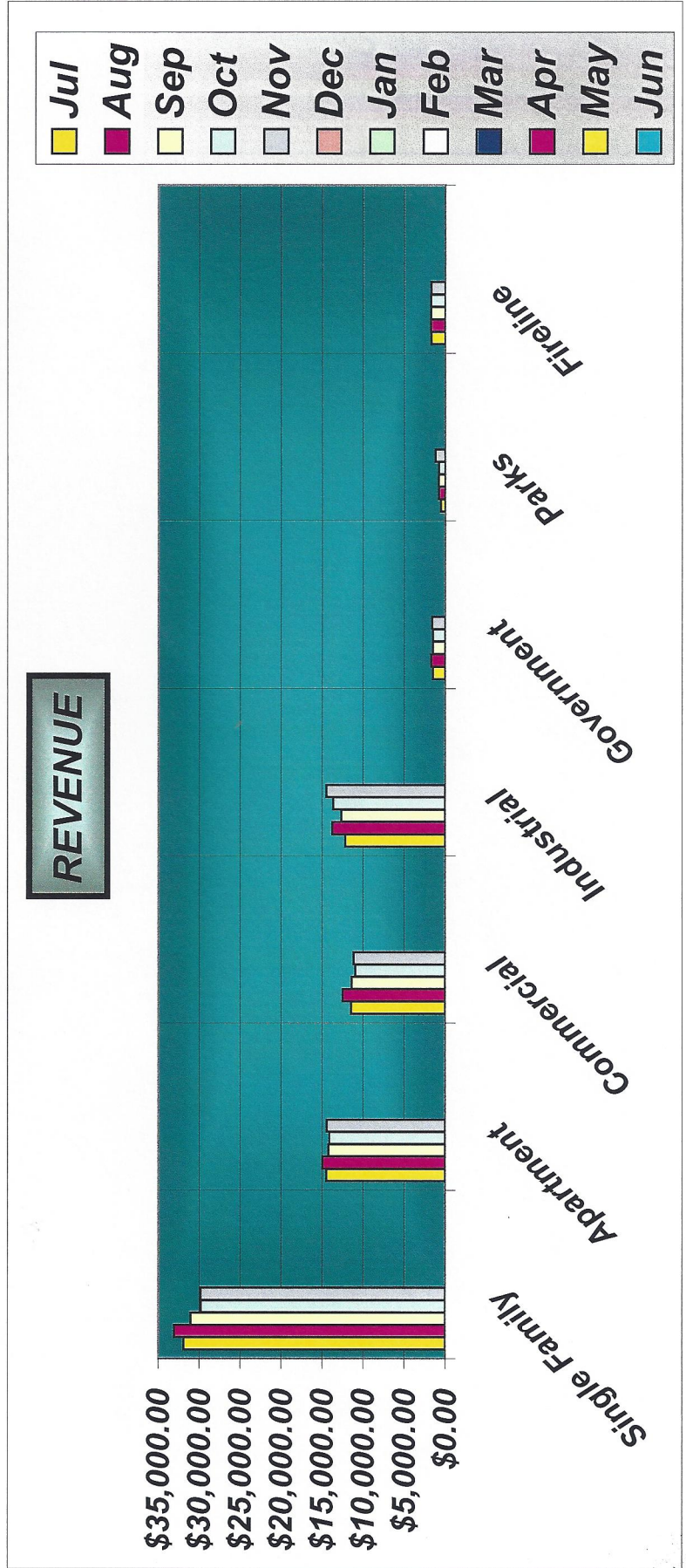

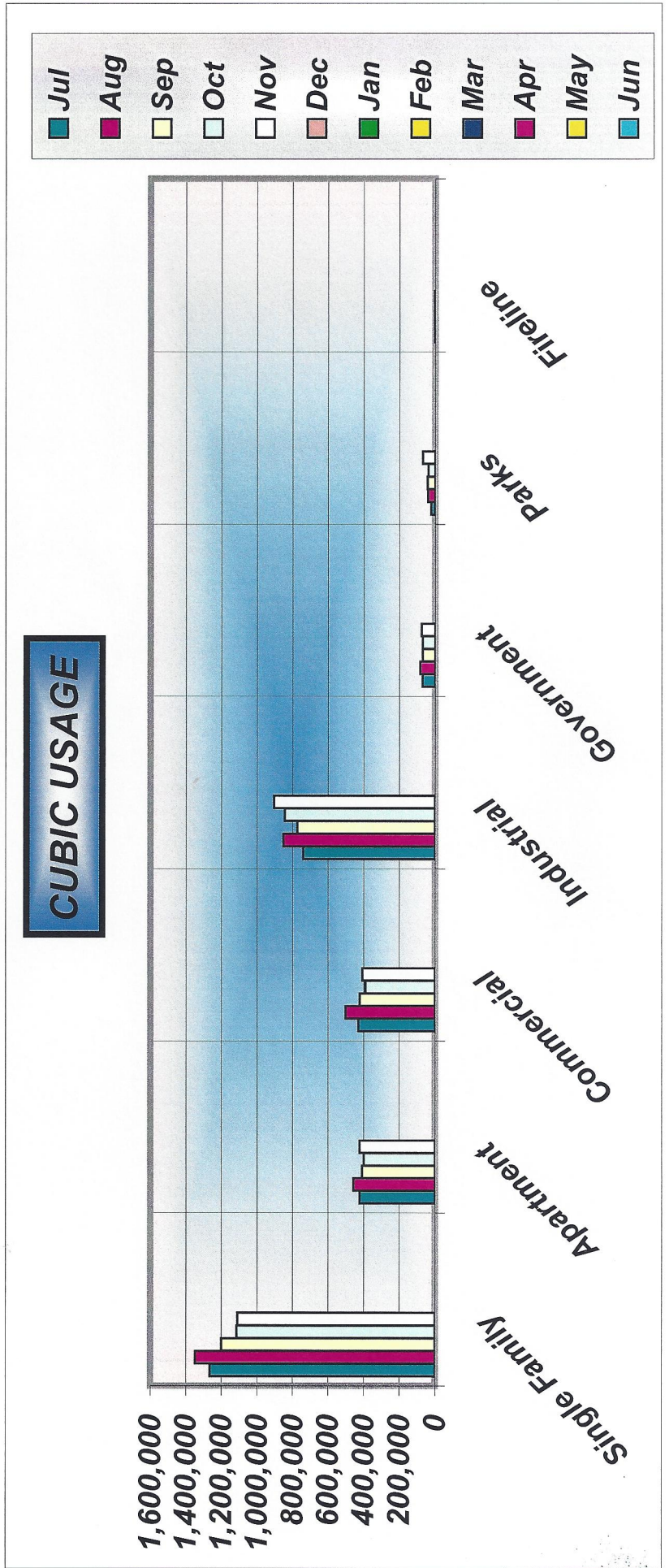

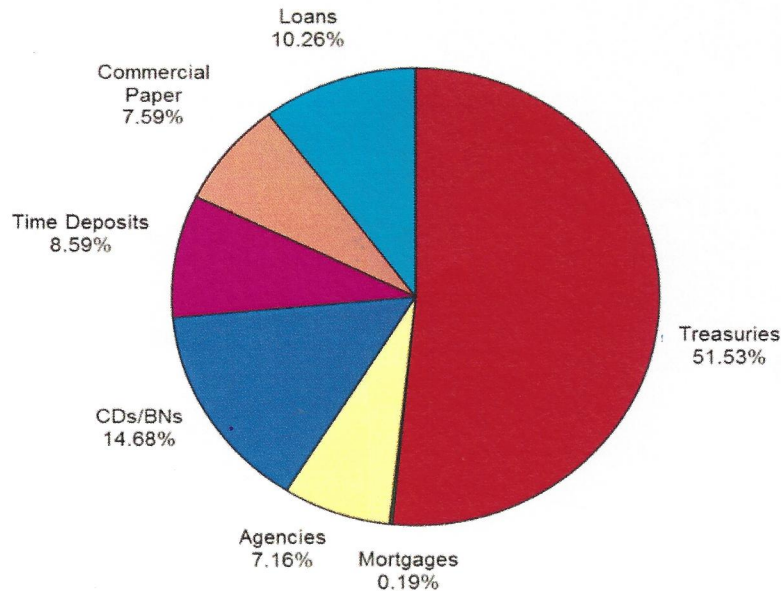
